This Reference Product comes from a site that have received ISO14001 certification..



■ DISTRIBUTION

Products are distributed from logistics centres located with a view to optimize transport efficiency. The Reference Product is therefore transported over an average distance of 780km by road from our warehouse to the local point of distribution into the market in Europe.

Packaging is compliant with european directive 2004/12/EC concerning packaging and packaging waste.

At the packaging end of life, its recyclability rate is of 100% (in % of the mass of the packaging)

END OF LIFE

Development teams integrate product end-of-life factors in the design phase. Dismantling and sorting of components or materials is made as easy as possible with a view to recycling or failing that, another form of reuse.

This product enters into the field of application of WEEE (2002/96/EC). It must therefore be processed through local WEEE end-of-life channels.

• End-of-life channel

The sale of this product is subject to a contribution to eco-organisations in each country responsible for managing end-of-life products in the field of application of the European Waste Electronic and Electrical Equipment Directive

• Recyclability rate

Calculated using the method described in the IEC/TR 62635 technical report, the recyclability rate of the product is estimated as 99%. This value is based on data collected from a technological channel using industrial procedures. It does not pre-validate the effective use of this channel for end-of-life electrical and electronic products.
